महोदय,

With reference to above it is to inform that India Security Press, Nashik had placed notification of award of contract/letter of intent no. PR/ML600/2021/4851 dated 16 Dec 2021 on M/s. Vraj Labels Private Limited, Ahmedabad for supply of 600 MT of Maplitho Paper with Hot Melt Adhesive (Pressure Sensitive) Coated and Backed with Silicone Coated Glassine Release Paper in Reel with Reel Width of 44 CMS. As per terms and conditions of notification of award of contract/letter of intent the firm- M/s. Vraj Labels Private Limited, Ahmedabad had to :-

(i) Submit the performance security deposit amounting to Rs. 33,02,820.00 /- (Rupees Thirty Three Lakhs Two Thousand Eight Hundred Twenty only) within 21 days from the date of issue of Notification of award of contract/letter of intent i.e. on or before 06/01/2022.

(ii) Supply the Five (5) reels as Pilot/Pre-Production on or before 15/01/2022 and bulk supply - 1st lot of 150 MT on or before 14/02/2022, 2nd lot of 150 MT on or before 15/04/2022, 3rd lot of 150 MT on or before 14/06/2022 and 4th lot of 150 MT on or before 13/08/2022.

2. However, firm wide email dated 22/12/2021 has denied the acceptance of notification of award of contract/letter of intent. ISP-Nashik has issued show cause notice dated 24/12/2021 for non acceptance of notification of award of contract however, the firm has again denied the acceptance of notification of award of contract/letter of intent.

4. Thus, in line with terms and conditions of tender and SPMCIL procurement manual guidelines, I am directed to inform that M/s. Vraj Labels Private Limited, Ahmedabad stands banned/blacklisted from participating in any of the tender of India Security Press, Nashik and all other units of Security Printing and Minting Corporation of India Limited (SPMCIL) for the next two (02) years w.e.f 04/01/2022. Further, M/s. Vraj Labels Private Limited, Ahmedabad has been removed from the approved list of vendors (i.e. vendor list maintained in ISP SAP system environment) for the period of two (02) years w.e.f. 04/01/2022.

5. The above referred notification of award of contract/letter of intent is hereby stands cancelled. Further, India Security Press, Nashik will take up the matter with Dept. of MSME and request Dept. of MSME to cancel the MSME registration of M/s. Vraj Labels Private Limited, Ahmedabad. Also India Security Press, Nashik will recover the extra expenditure, if any incurred for arranging such procurement at risk and cost of the supplier i.e. M/s. Vraj Labels Private Limited, Ahmedabad in line with clause 26.2 General Conditions of Contract (GCC) of tender terms and conditions.
