This is with reference to Non supply of material & not supply the material as per technical specification of the tender to BNP, Dewas.

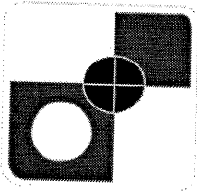

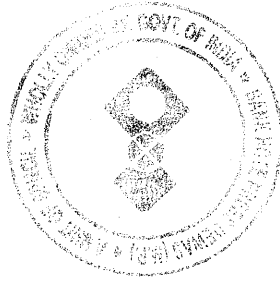
